**Housing Payments:** There is no housing provided during PHASE ONE (Meeting the Pre-Requisites -- Participatory Arts) or PHASE TWO (Independent Study) of the SMTT. **Payment for housing and food during PHASE III is a separate fee** paid directly to Earthdance and to a dorm in NYC if you need housing there. Moving On Center will be pays a deposit on your behalf the Autumn before EarthDance. Please take this into consideration when making your plans. This year Earthdance housing is \$650. Many questions can be answered by visiting both the Moving On Center and the EarthDance web-sites.

**College and University Credit:** Each college or university has a distinct set of financial constraints.

**Late Payments:** Starting **February 1<sup>st</sup>, 2010** late payments will warrant a fee of \$15 for every week of lateness.

**REFUND POLICIES:** All refund requests must be submitted in writing. Your request will be considered by the Director of the Program in terms of how much interim work and class work has already taken place in your training process. Refunds are calculated according to the following regular and discounted DE-SMTT payment schedule:

- 1.) The tuition deposit (\$500) is nonrefundable after December 1, 2009.
- 2.) The second payment is nonrefundable as of March 1, 2010.
- 3.) The third payment can be refunded on a pro-rated basis, minus an administrative fee, based on how many days the student has attended the program. After the second week of the final SMTT training, this payment is non-refundable.

Please inquire with the Director of the Program to process refund requests for any payment plan.
