Application to the DE-SMTT is best communicated by Sept 15, 2011 to be eligible for tuition discounts. All students are asked to meet with and begin planning for their study with Martha Eddy by November 2011 if physically possible (Skype meetings can be arranged). Applications may however be submitted earlier. There is rolling enrollment until the first day of the training until the program is full (20 students) but a late application fee is assessed after Feb 1, 2012.

## D. Acceptance/Enrollment/DE-SMTT Tuition Deposit:

Martha Eddy holds the right to accept only those students with whom she has had direct (phone, written or in-person) and satisfactory discussion confirming the appropriateness of the training at this time. You will receive notification of your status within four weeks of the receipt of your application. Upon acceptance to the DE-SMTT, your contract including Financial Agreement page needs to be signed and mailed to Moving On Center-NY to activate your participation in DE-SMTT.
